**RE:** New Business F–Spring Plant Replacements

Lancaster and Management walked all the wards and made a list of all the dead shrubs and suggested replacements for each. Typically, varieties are changed to more suitable plant varieties to satisfy the existing environmental factors. This increases the success rate of the plantings. With this year's list in particular, an emphasis was made to use native plants wherever possible with the hopes that these natives will offer better survivability making the program more sustainable over time.

The remaining funds in the Grounds Committee budget for this specific purpose is \$5,650.00. Lancaster's proposal totals \$6,772.00 which creates a line-item deficit of (\$1,122.00). Other areas in Grounds Improvements (#6145) have enough remaining budget to cover the deficit.
