Consider Running for Our Board by January 28

THREE OPEN POSITIONS

Three of the nine positions on the Board of Directors will be open for election at North Fairlington's Annual Meeting on Wed., March 30, 2022. Three Board of Directors seats will be up for election in 2022:

√ Ward I

√ Ward VI

√ One At Large position.

The Ward I position currently held by Jessica Auston, the Ward VI position held by Melanie Alvord, and the At Large position held by Terry Placek, will each be up for 3-year terms.

The Fairlington Villages Board of Directors is an all-volunteer body of nine members who represent the entire community (three) and each ward (six). The positions are not compensated. The Board typically meets the first Wednesday of each month at 7 p.m.

CANDIDACY CRITERIA

Candidates must own a unit in Fairlington Villages; be current with condo fee payments; and reside in the ward in which they are running, except for an At Large seat. Candidacy petitions will be reviewed to confirm eligibility and certified by the Board at its Wed., Feb. 2 meeting.

Homeowners may obtain election rules at the Management Office. For more details on how to become a candidate or questions about the election process, please contact the Management Office or a Board member.

Defining Our Boundaries

The Association will be retaining the services of a property surveyor company to update the Association's Site Survey file and to confirm whether the community's fencing is Fairlington's to maintain. The property survey should be completed by the end of March 2022. The process of conducting the survey will not affect residents in any way, but you may see contractors walking the property with survey equipment.

The Association's perimeter follows along King Street to the West, Interstate 395 to the South, Park Shirlington and Abingdon Elementary School to the East, and The Arlington Condominium to the North. Approximately 75 percent of Fairlington Villages' perimeter is bounded by a discontinuous run of vintage chain-link fencing.

Assuming the fence surrounding Fairlington Villages' is its own responsibility to maintain, Management will prepare a comprehensive, multi-phased program to take place over the course of several years for the Board's consideration. That proposal will offer one or two materials replacement alternatives for the existing fence,

Every Garden Deserves a Second Chance

The Grounds Committee and other Fairlington Villages gardeners volunteered more than 16 hours, to upgrade the Pilot Shade Garden at 2934 S. Columbus St., over the October holiday weekend. This next phase of the native plant initiative has been implemented to mitigate erosion and soil compaction where grass will not grow. Improvements included additional native plants, along with a pathway to allow mail carriers and residents to efficiently cross the area.

The Pilot Shade Garden, which was planted in the fall of 2019, demonstrates which native plants do best in the many shady, sloped environments we have in Fairlington Villages. These natives have evolved in this area to withstand weather extremes and have large

root systems that prevent erosion and break up compacted soils.

We hope this garden can be an asset to all residents who are looking to replace the English ivy, Japanese pachysandra, vinca, and other invasive ground covers that we, as a community, are trying to eliminate in common areas (foundation plantings) and patios. Plant species will be labelled, to assist you in purchasing, and we have suggestions for local nurseries that supply these plants at good prices.

Board Selects High Sierra Pools as 2022 Pool Season Contractor

The Board of Directors selected High Sierra Pools to provide pool management, maintenance, and lifeguard services for the Association's six pools for the 2022 pool season at its Dec. 1, 2021, meeting. The contract's \$157,560 cost reflects both rising prices in the pool service industry and Virginia's recent minimum wage increases, and is \$5,075 less than the \$162,635 programmed for this contract in the Association's Fiscal Year 2022 (FY22) budget.

ABOUT HIGH SIERRA POOLS

High Sierra Pools was founded in 1992 and operates more than 700 pools for condominium associations and other clients in the Washington metropolitan area. The company plans to build on its previous 2021 experience in successfully operating a large number of pools during the COVID-19 pandemic, and intends to staff our six pools with a mix of domestic and international lifeguards during the 2022 pool season.

THE BIDDING PROCESS

The Board chose High Sierra to operate our pools following competition for a contract to succeed the agreement for pool maintenance and lifeguard services provided by Premier Aquatics, whose three-year contract ended in 2021. Six pool contractors were invited to bid on the Fairlington Villages contract and four contractors submitted bids: High Sierra, Premier Aquatics, Winkler Pools, and Sunset Pools.

As part of the bidding process, the Board conducted in-person interviews with the four contractors that submitted bids on the evenings of November 15 and 16. Board members asked each bidder to answer a standard, prepared list of questions to establish which contractor had the best plan for staffing and management of the Association's pool facilities. The Board made its decision to award the contract to High Sierra based on several factors, including cost, staffing plans,

pool management and customer service procedures, and the company's incentives for promoting lifeguard morale.

The Board is confident that the selection of High Sierra Pools will lead to a successful 2022 pool season and looks forward to working with the new contractor.

FY22 POOL EXPENSES

Besides the \$157,560 cost of the High Sierra contract, the FY22 budget includes an additional \$65,000 for routine pool repairs and supplies, including chemicals, Arlington County and City of Alexandria operating permits, and lifeguard safety equipment. When these expenses are added to the amount of the High Sierra agreement, the total 2022 cost of operating the Association's pools will be approximately \$223,000.



Avoid a Tow! Collect Your 2022 Parking Decal

YOUR 2021 DECAL IS NOT VALID IN THE NEW YEAR

The shape of the 2022 parking decal is a pentagon. The 2022 decals are available at the Management Office. All Fairlington Villages 2021 parking decals in the shape of a circle expired on Fri., Dec. 31, 2021. As of Jan. 1, 2022, vehicles without a visible valid 2022 decal in the shape of a pentagon in Fairlington Villages' parking lots are subject to immediate towing at the owner's risk and expense, with no regard to whether expired permits are displayed.

DECAL REQUIREMENTS

To be issued a 2022 parking decal:

- Condominium assessments for the unit must be paid and current.
- A current lease must be on file for rental units.

A current automobile registration must be presented for each vehicle for which a permit is being requested.

No decal may be issued unless each of these requirements is met—there are NO exceptions. Read the <u>Parking Enforcement Policy online</u>. Do not towed; get your new decal today.



GET YOUR DECAL ASAP

We urge you to visit the Management Office at your earliest opportunity. Please wear your mask and practice social distancing when you visit. For safety, only one visitor or family will be admitted to the Office at any given time.

You can schedule an appointment to avoid waiting outside. The Management Office is open Monday through Friday from 8:30 a.m. to 5:30 p.m. and on Saturday from 9 a.m. to 2 p.m. except for holiday hours. We will be closed on Fri., Dec. 31 for New Year's Eve and Sat., Jan. 1 for New Year's Day. We will also be closed Mon., Jan. 17 for MLK Jr. Day, but please do not wait that long!

Holiday Tree Disposal Begins January 4

Fairlington Villages participates in the tree recycling program with Arlington County to keep holiday trees out of the landfill; Capitol Services will haul trees on four days in January. Please hold your trees until collection begins on Tues., Jan. 4. Follow these easy steps:

- Place your tree curbside by 12 p.m.: Tues., Jan. 4; Thurs., Jan. 6; Tues., Jan. 11; and Fri., Jan. 14.
- For your tree to be recycled, Arlington County requires the tree be clean of any decoration.
- If you used a bag, remove the bag once you get the tree to the curb.
- If you live in an apartment building, please remove any needles and debris from the stairwell and hallways, as they are difficult for the cleaning crew to remove with their vacuum.

While none of us wishes to battle the snowfall of a Snowmageddon, we have made preparations for a typical snowfall in 2022. This vintage photo shows Fairlington employee Ken Thompson plowing snow from a parking lot in Ward 2 during the record snowstorm of December 2009.

In the event of snowfall, the goal is to remove snow promptly, but many factors determine how we approach snow removal. Typically, our priorities are as follows:

- 1. Clear streets so emergency vehicles can access the property.
- 2. Clear accessible areas of parking lots, building steps, and entrance walkways.
- 3. Clear snow from all other sidewalks.

4. Sand and chemicals will be applied throughout the community as needed. Fairlington uses sodium chloride (Halite Rock Salt) to treat streets and magnesium chloride (Ice Melt) on sidewalks.

Above all, please be patient as we work to make our way through the weather event. Learn about our snow removal efforts in greater detail in the December 2021 issue of our newsletter.
