I. Residents' Comments

II. Call to Order

At 7:00 p.m. President Placek called the regular agenda to order.

III. Establishment of Quorum

President Placek noted there was a quorum with eight members present all by teleconference connection. She noted the absence of Ward I Director Jessica Auston.

VII. Reports

President: President Placek noted that this was a very sad day for the Nation, given that a mob had forced its way into the Capitol Building after participating in an election protest called to support President Trump. The president had spoken and urged his supporters to march on the Capitol Building where legislators were debating approval of Certification of Electoral College Votes for President of the United States. She asked those attending to pray for the Country with the hope that this sort of mob action would not also take place on Inauguration Day. Her sentiments were echoed by a number of the Members of the Board and Staff.
