

## October 2024 Vol. 46, No. 10 **Recognizing New Signs in Our Historic Association**

Our colonial revival community now has enhanced cache, with the placement of five signs designating the City of Alexandria section that encompasses Ward VI as the Fairlington Historic District.

The signs were installed under the City of Alexandria's Wayfinding program, which has placed more than 300 signs that orient visitors and residents to the city's historic civic locations, parks, and points of interest.

The city's Transportation and Environmental Services' (T&ES) Traffic Operations group in fall 2023, began planning to install Historic District signs in the city-portion of Fairlington and in Parkfairfax, both of which are on the National Register of Historic Places. These signs previously were installed in the city's two other National Register communities: Del Ray and Rosemont.

The Fairlington signs' design was a collaborative effort between T&ES and the Fairlington Historical Society (FHS).

It was asked to identify "a typical landmark or building within the Fairlington community," Beth Hoffman, the FHS's president, said in a September interview.

Its members reviewed photographs of Fairlington buildings that were submitted to support the community's application to be listed as a Virginia Historic Landmark and on the National Register of Historic Places, granted in 1998 and 1999, respectively.

## Homeowners' Basis Includes Portion of Annual Condominium Fees

Fairlington owners following the value of their home on the real estate market should be aware that they may face a potential tax hit should they sell, but also that a portion of their condo assessments paid through the years contributed to the capital reserve fund may cushion the blow.

Current tax law grants individual homeowners a \$250,000 exclusion (\$500,000 for joint filers) from capital gain on the sale of a primary residence. Many individuals who own Fairlington homes may have exceeded the tax exclusion if they have lived in their home for a long period. However, the tax code allows home improvement expenditures, such as renovations and other substantial changes, to be added to an owner's tax basis, or cost of the home.

Condo owners' structural home improvement options are limited by covenant. The condo association *continued on page 3* 

# Turf Care Begins with Chelated Iron

In September, in preparation for the first application of leaf compost tea, the Association's landscaper, Lancaster Landscapes, did spot treatments for weeds using an organic, chelated iron herbicide. Chelated iron was applied selectively in areas with dense weeds, where the weeds might inhibit grass growth and undercut the effectiveness of leaf compost tea. A single application of the herbicide may be sufficient.

Where some mineral micronutrients in herbicides, including iron, manganese, copper, and others, break down easily, which changes their chemical properties and lessens their ability to create healthy soil, chelated iron works differently. It is soluble and is more easily taken up by plants. It also acts as an herbicide for broadleaf weeds because these weeds absorb chelated iron products more readily, and in higher quantities, than turf grass. This absorption causes the weeds to quickly dry up and die, without any long-term or adverse impact on turf grass, thus clearing the way for new turf grass growth in those areas.

The first application of organic leaf compost tea will be sprayed on the turf grass in early October. It is a liquid brine made from composted leaves and will deliver natural nutrients and vital microorganisms to our soil, which will "wake up" the soil to support healthy turf growth above and below ground.

A second application of leaf compost tea will be done in the spring. As the soil regenerates itself, the turf should flourish in areas where grass is able to do well, and the need for leaf compost tea applications will be reduced with the potential for skipping a year between treatments.

Leaf compost tea is non-toxic for humans, pets, wildlife, and the environment. It is safe to walk upon immediately after it is sprayed. The only downside is you may get muddy feet if you walk on it while it is wet.

While it may take a season or two to achieve the accruing benefits of leaf compost tea, we may be able to observe some positive changes as early as this spring.

said the design image was refined, working with a member of the city's urban planning staff.

Siting the signs also was a collaborative effort. Hoffman, along with Mary Konsoulis, the Wayfinding Coordinator with T&ES' Traffic Operations, and another T&ES staff member, walked Ward VI looking for high-visibility locations.

The signs were fabricated by the city in-house, with each site then checked "with Miss Utility for any underground utilities," Konsoulis said in a September email. The signs were dropped "into the historic district template provided in the Wayfinding guidelines," she said.

City workers installed the signs in September at the following locations:

- King Street and S. 28th Street;
- Columbus Street near S. 28th Street;
- Dinwiddie Street and S. 29th Road.;
- Columbus Street off of the S. 30th Street Circle;
- King Street and S. 30th Street.

As of Jan. 1, 2025, vehicles without a visible valid 2025 decal in Fairlington Villages' parking lots are subject to immediate towing at the owner's risk and expense, with no regard to whether expired permits are displayed.

#### DECAL REQUIREMENTS

To be issued a 2025 parking decal:
Condominium assessments for the unit must be paid and current.
A current lease must be on file for

rented units.A current automobile

registration must be presented for each vehicle for which a permit is being requested. No decal may be issued unless each of these requirements is met — there are NO exceptions. is, to varying degrees, responsible for infrastructure maintenance. The IRS allows the portion of a condo assessment that is attributable to capital improvement — basically, reserve contributions — to be added to basis.

The IRS has accepted that reserve contributions may constitute tax basis step-up. Sellers should confirm with their accountant or tax advisor. Since 1986, the Association has tracked the annual amount of each model's contribution that may be added to basis. The math is simple: multiply the total annual reserve contribution by the unit's percentage of Association equity. Management maintains a spreadsheet listing each model's step-up by fiscal year; it is available upon request.

For example, a Clarendon II's reserve contribution in Fiscal Year 2024 is \$1,978. Since the start of Fiscal Year 2000, the reserve total is \$35,538. That means that an owner who purchased the unit on Oct. 1, 1999, and is closing its sale on Sept. 30, 2024, may add \$35,538 to the purchase price basis of the unit for tax purposes.

To continue the hypothetical: If an individual bought the unit for \$200,000 and sold it for \$500,000, the proceeds after adjusting the basis would be \$264,462, and \$14,462 would be subject to capital gain treatment. (Joint filers would face no taxable gain.)

In a real case, an owner would prorate annual basis adjustments for purchase and sale years to reflect the number of months of paid condo fees. Unit owners also may receive a step-up in basis for the cost of new appliances, replacement windows, and other qualified home improvements.

#### **Condo Fee Increase of 3.39% for Fiscal Year 2025**

A copy of the Fiscal Year 2025 (FY25) budget and payment coupons was mailed to you last month. If yours has not arrived, please contact the Management Office to request a replacement. Please remember that monthly assessment payments are due by the 1st of each

month. There is a grace period through the 15th of each month, after which date a late fee of \$25 will post to your account.

Assessments have increased by 3.39% for FY25 from Oct. 1, 2024, through Sept. 1, 2025. Please remember to verify that your account payment amount is accurate. There are four payment methods available:

- 1. Legum & Norman/Associa ACH direct debit (automatic adjustment).
- 2. Credit card or e-check offered through Associa/ TownSq (requires manual adjustment by you); you can create your account with TownSq online: <u>https://app.townsq.io/login</u>.
- 3. Coupon payments by check (automatic adjustment).
- 4. Online bank bill payer accounts (requires manual adjustment by you).

# **Board Meeting Highlights**

The Board held a Regular meeting on Sept. 4, 2024. The following are highlights.

**New Business** A. Masonry Repair Project Phase 10 (FY24) – Additional Funds: Mr. Faherty moved the Board authorize Management to sign the change Order with American Restoration in the amount of \$58,195 to cover the increased cost of additional work needed on the parapet walls. The total cost of Phase 10 of the Masonry Repair Program (FY24) is as follows: Masonry Repairs (American Restoration) \$479,945; Consulting and Construction Assurance/Contract Admin. (FEA) \$33,700; TOTAL \$513,645. Passed 9-0.

**B. Slate Roofs Preventive Maintenance Program – Wards III and IV (FY25):** Mr. Reem moved the Board authorize Management to contract with Northern Virginia Roofing, to provide preventive maintenance repair services on the slate roofs located in Wards III and IV at a cost not to exceed \$32,500. Passed 9-0.

**C. King Street Tree Planting** (FY24): Ms. Alvord moved the Board approve the following proposal from Lancaster Landscapes for tree planting along King Street at a cost not to exceed \$23,000. Passed 5-3-1.

## Safe Grilling Techniques Are Easy to Master

As you take advantage of the last days of cooking outdoors with family and friends, please be mindful that the Virginia Fire Prevention Code (VFPC) prohibits the use, operation, or storage of

any open-flame cooking device on any balcony, rooftop, or deck of any building or

within 15 feet of combustible construction or residential occupancy. The VFPC provides an exception for cooking devices using electricity as the heating source and listed by a recognized testing authority. Violations can result in jail time and a \$2,500 fine.

Be sure to follow these grilling safety tips from the Arlington County Fire Department:

- Grills must be used outdoors. Use of a grill indoors or in any enclosed space poses a fire hazard and risk of exposure to toxic gases and potential asphyxiation.
- Position the grill 15 feet away from siding, deck

railings, other combustibles, and out from under eaves or overhanging vegetation.

 Keep children and pets away from the grill area – declare a 3-foot "safe zone" around

the grill.

• Place the grill a safe distance from lawn games, play

areas, and foot traffic.

- Do not leave cooking unattended.
- Put out several long-handled grilling tools to give the chef plenty of clearance from heat and flames.
- Periodically remove grease or fat buildup in trays below the grill so it cannot be ignited by heat.

- 2. Do not leave burning candles unattended, including Jack-O-Lanterns.
- 3. Kindly refrain from applying cobwebs or spiderwebs to the landscaping.
- 4. Please remember that all Halloween decorations are permitted from October 15 to November 8.
- 5. Do not hide extension cords under rugs.
- 6. Any exterior decorations outside of these specific ranges of dates requires a Variance request to the Board of Directors.
