# Three November Dates for Leaves

When cleaning leaves and other yard debris from your backyard this fall, please consider recycling them in the free brown paper yard waste bags available at the Management Office. During the month of November, the Association partners with our trash hauler, Capitol Services, to pick up the bags curbside and transport them to the Arlington County Trades Center where they are composted into black soil which is made available to Arlington County residents.

Collection will be on three Thursdays at 12 noon: Nov. 7, Nov. 14, and Nov. 21.

Yard waste collection bags are provided for residents at no charge from the Management Office; stop by to collect your parking decal at the same time!

Please note, we will not make any reservations without payment of the Rental Fee and the Security Deposit at the Management Office. The Security Deposit will be refunded 2-4 weeks after your event as long as the room is in the good condition it was before the event.

# Restrictions

Events are limited to 100 people and no items or decorations can be placed on the walls, ceiling, windows, or curtains. All indoor furniture must remain within the Community Center and cannot be moved to the patio. Please see the **Rental Form** for complete details on restrictions.

The keys to Community Center can be picked up from the Management Office at 3001 S. Abingdon St. during our normal business hours. For events taking place on Sunday, you need to pick up the keys no later than 12 noon on Saturday. Failure to pick up the keys may

# Fall Patio Yard Cleanup Made Easy

Help our pollinators and songbirds by minimizing your yard cleanup with these three easy steps.

- 1. Leave the heads and stems. Seed heads from purple coneflowers and black-eyed Susans, among other plants, continue to feed the birds after the blossoms have faded. Also, several of our native bees and other insects overwinter in the stems of plants that leave woody-type stems. If there no longer is a seed head, you can help the insects by cutting the plant stems back by half; or cut to the ground, gather the cut stems, and lean them against the fence in a corner.
- Fallen leaves provide habitat and food for wildlife. Many of our native moths and butterflies overwinter in fallen leaves either in the form of caterpillars or chrysalises. Many insects live or hibernate in the fallen leaves, and all are food for birds, chipmunks, turtles, and salamanders. Some butterflies and fireflies lay their eggs in leaf litter. If we toss all those

2. Leave the leaves, too.

Too many leaves will damage or kill the lawn by smothering it. Yard waste collection will be on three Thursdays at 12 noon:
Nov. 7, Nov. 14, and Nov. 21.
During the last leaf collection, they will leave the leaves behind our units in the shrub borders, around trees, and in the wooded areas. Those leaves help retain moisture

in the soil around the tree's roots, and, when they break down, provide organic matter to the soil around the tree. The fallen leaves also provide a soft landing for caterpillars and chrysalises that fall out of the tree in autumn to look for a warm safe place to overwinter.

# 3. Wait for fifty.

Do spring cleanup after temperatures are consistently above 50 degrees Fahrenheit day and night. Our native insects will emerge by then and be busy pollinating our spring flowers and our songbirds' babies will start to hatch.

# Please Dress Up Your Decor Safely

The ghosts of Halloween might still be with us, but we should not need to be afraid of our decor! As many Fairlingtonians are getting cozy and turning their thoughts to decorating for the winter holidays around the Village and the common elements, please keep the safety of our neighbors and the health of our landscaping in mind.

- 1. Halloween decor is permitted through Fri., Nov. 8.
- 2. Year-end holiday decorations are permitted Fri., Nov. 15 to Wed., Jan. 15.
- Any exterior decorations outside of the specified date ranges require a Variance request to the Board of Directors.
- 4. Keep the stairways and sidewalks free of ground level decorations (e.g., pumpkins/ gourds, bales of hay, lanterns etc., making sure all handrails are accessible to those needing them.
- Remove packages from your porch promptly, leaving it clear for postal workers or other deliveries.
- 6. Do not leave any burning candles unattended, including Jack-O-Lanterns.
- Kindly refrain from applying cobwebs or fake snow to the landscaping; it can be harmful to birds and other wildlife.
- 8. Do not hide extension cords under rugs.

# Thankful for Good Pet Parents in the Village

Pet owners are reminded that the Arlington County and City of Alexandria Codes, as well as Fairlington Villages' Rules and Regulations, require dog(s) be kept on-leash while in public spaces. Management is receiving many complaints on the subject. Visit the BringFido online listing of parks where dogs can be offleash. In the City of Alexandria: Eugene Simpson Stadium Park and Founders Park. In Arlington County: Benjamin Banneker Park, Clarendon Dog Park, Dog Park at Fort Barnard Park, Glencarlyn, James Hunter Dog Park, Madison Community Canine Area, Shirlington Park, Snouts & Stouts, Towers Park, and Utah Park.

And of course, please be sure to scoop the poop and use the proper bins for dog waste disposal!

Please know that excessive dog barking violates our noise rule. Excessive barking is defined as at least once per minute for 10 consecutive minutes in Arlington County, or "heard for more than five consecutive or non-consecutive minutes in any 10-minute period of time" in the City of Alexandria.

### **DECAL REQUIREMENTS**

To be issued a 2025 parking decal:

- Condominium assessments for the unit must be paid and current.
- A current lease must be on file for rented units.
- 2025 • A current automobile registration must be presented for each vehicle for which a permit is being requested.

No decal may be issued unless each of these requirements is met — there are NO exceptions. You can read the Parking policy in our Fairlington Villages Handbook for *Residents*, please see the "Rules" section on page 71 online.

# Decorating with November Dates and Safety

Please keep stair-steps, railings, and sidewalks clear of seasonal decorations for safety.

Please remember that Halloween decorations must be removed by Fri., Nov. 8. Year-end holiday decorations are permitted from Fri., Nov. 15 to Wed., Jan. 15.

Permission may be granted to decorate the common area of multiunit buildings (e.g., front door, porch, hallway, stairway) if residents all agree on the décor and present a "Request for Decorating Shared Common Areas Approval Form" available online.

### Remember to Turn Off Outside Water Faucets

With the approaching potential for extended freezing temperatures, please be sure to turn off the supply valve for your outside water faucet, also referred to as a hose bibb or spigot. This reminder applies to all townhouse residents and those multiunit building residents with unit space in the basement: A-level apartments or B-level units with basement storage.

If you have an outdoor faucet shutoff valve within your control, it is your responsibility to shut off the water at that location for the winter. If the pipes freeze and cause damage, the repair costs could be significant and charged to you. If you are unsure whether you are responsible for a water faucet shutoff valve, please contact the Management Office.

improvements as development moved from South Fairlington to North.

As a result of engineering "field adjustments," the physical placement of the water main shutoff valves in the multiunit buildings is not consistent. The Association does not know and cannot confirm which of the four to six water main shutoff valves in the multiunit buildings serves which of the units. Any tags that might be found on valves inside the cabinet were placed there by the developer at the time of conversion; a master listing was never provided to the Association and the labels have not been maintained.

The unit owner is responsible for the valve and related maintenance. If you reside in a multiunit building and need to have your water main replaced, please have your plumber confirm which valve is yours before any work is started. You do not want to go through the expense of a valve replacement only to discover the valve serves your neighbor's unit!

# **Board Meeting Highlights**

The Board of Directors held a Regular meeting on Oct. 2, 2024. The following are highlights.

**New Business** 

A. Rules Violation – Hearing: Ms. Alvord moved that having conducted the Hearing and following the review and evaluation of all evidence the Board assesses \$50 for the Rules Violation and that the matter be sent to Legal Counsel for an opinion on the matter, in particular how it may be governed by Article 6, Section 8 of the Bylaws. Passed 7-0 with President Torres not participating in the vote.

B. Employer's Voluntary Contribution to a Simplified Employee Pension (SEP) Plan: Mr. Faherty moved the Board authorize a Voluntary Employer Contribution equal to 4% of gross compensation for all eligible employees, for the period of Oct. 1, 2023, through

Sept. 30, 2024. Passed 8-0.

C. Transfer of FY24 Excess Assessments to FY25: Mr. Reem moved the Board authorize that any excess of membership assessments collected over and above the member operating expenses of the condominium for the fiscal year ending Sept. 30, 2024, shall be applied against member assessments for fiscal year 2025, commencing Oct. 1, 2024, as provided by Revenue Ruling 70-604. Passed 8-0.

**D. Rotten Wood Replacement** Ward IV: Mr. Faherty moved the Board authorize Management to contract with Middledorf Property Services, Inc., for rotten wood replacement in Ward IV at a cost of \$338,612. Passed 8-0.

E. Community Center Renovation:

Ms. Lankford moved the Board table the resolution on renovation of the Community Center and authorize Management to work with the designer, and two members of the Board, to combine aspects of both designs. Passed 8-0.

F. Fall Plant Replacements: Mr. Faherty moved the Board authorize Management to contract with Lancaster Landscapes, Inc., for replacement plants at a cost of \$14,737. Passed 8-0.

**G. Ward V Renovation Planting:** Mr. Faherty moved the Board authorize Management to contract with Lancaster Landscapes, Inc., for the Ward V Renovation Planting at a cost not to exceed \$30,000 with priority given to enhancements. Passed 6-1-1.
